1. Whereas, the AICTE is a statutory body established by AICTE Act, 1987 to provide for establishment of an All India Council for Technical Education with a view to the proper planning and co-ordinate development of the technical education system throughout the country, the promotion of qualitative improvement of such education in relation to planned quantitative growth and the regulation of proper maintenance of norms and standards in the technical education system and for matters connected therewith."
2. Whereas, Section 10 of the AICTE Act prescribes the function of the Council and mandates that it shall be the duty of the Council to take all necessary steps and it may think fit for ensuring coordinated and integrated development of technical education and maintenance of standards, Section 10 (k) of the AICTE Act, empowers the AICTE to grant approval for starting new Technical Institutions and for introduction of new courses or programmes in consultation with the agencies concerned and Section 10 (q) empowers the AICTE to withhold or discontinue grants in respect of courses, programmes to such technical institutions which fail to comply with the directions given by the Council within the stipulated period of time and take such other steps as may be necessary for ensuring compliance of the directions of the Council.
3. Whereas, in order to discharge its duties in accordance with the provisions contained in the AICTE Act the AICTE has framed the regulations for grant of approval for starting new Technical Institutions, introduction of courses or programmes and increase / variation of intake capacity of seats for the courses or programmes of existing Technical Institutions. The AICTE has also evolved a Hand book for approval process which details with the procedure as well as minimum conditions which an Institute must fulfill in order to seek approval for either starting new Technical Institutions or for introduction of courses / programmes as increase / variation of intake capacity of seat for courses / programmes as well as existing Technical Institute.
4. Whereas, a Surprise Visit was conducted on 28.03.2012 to the institute under 5% cases which noted nos. of deficiencies.

5. Whereas, "No EOA for A/Y 2013-14" was issued to the institute as per the recommendation of SAC dated 11.12.2012 and decision of the Council dated 22.02.2013 for its implementation from the A/Y 2013-14.
6. Whereas, Institute filed a Writ Petition (C) no. 17984 of 2013 in Hon'ble High Court of Kerala against the No EOA for A/Y 2013-14.
7. Whereas, a SAC was conducted on 21.08.2013 by allowing one more chance to the institute as per APH. The representative of the institute was also present. The recommendation of the SAC was that EOA may be given for A/Y 2013-14, keeping the decision of Court applicable.
8. Whereas, the Council has decided that the EOA for the A/Y 2013-14 may not be granted at this stage and institute can apply for EOA 2014-15.
9. Whereas, Institute has applied for the grant of EOA for 2014-15. The matter was placed before SAC in which representative of the institute was also present. The recommendation of SAC was as under:


"In view of the order of Hon'ble High Court Kerala dated 25.03.2014 the WP (C) 7218/2014 the application for EOA for A/Y 2014-15 be considered and/granted as per AICTE norms."

10. Whereas, an EOA for 2014-15 was issued to the institute.
11. Whereas, a Complaint was received from the EPFO intimating violation in compliance under EPF and MP act 1952.
12. Whereas, a Show Cause Notice was issued on 28.04.2015 to the institute based on the complaint letter from EPFO. Institute was asked to be present before SAC on 30.04.2015 along with relevant documents.

13. Whereas, the matter was placed before SAC on 30.04.2015, in which institute representative of the institute was also present. The recommendation of SAC was as under:

"As per brief status of the case, given by Approval Bureau, a letter from E.P. F.O, Ministry of Labour, dated 4.02.2015. is received wherein it is stated that the institute has not deposited EPF dues amounting to Rs. 30,44,348/- which has not been deposited by the establishment, hence a complaint under section 406/409 I. P. C. has been filed to the police authorities

14. Whereas, an EOA for A/Y 2015-16 was issued to the institute on 30.04.2015
15. Whereas, a letter no. 17978/J2/13/H.Edn. dated 16.04.2015 was received from Additional Chief Secretary Govt. of Kerala, pointing out nos. of irregularities in institute and requested the AICTE to withdraw the approval to the institute.
16. Whereas, The matter was placed before the SAC on 15.07.2015, which recommended as under:



- EVC is recommended to verify the fact as narrated in the letter dated 16.04.2015 from Additional Chief Secretary, Govt. of Kerala. Further, in addition to the verification of infrastructure and other details, EVC be asked to furnish its point-wise observation of the points highlighted by additional Chief Secretary to accomplish this, EVC be supplied with the relevant letter and other documents.
- Concerned RO, be asked to procure the copy/copies of complaints, inquiry report and other relevant documents concerning the inquiry that was completed and finds mention in the aforesaid letter from Additional Chief Secretary.

17. Whereas, an EVC was conducted to the institute on 11.08.2015, which noted nos. of deficiencies.
18. Whereas, the matter was placed before SAC on 22.09.2015, in which institute representative of the institute was also present. The recommendation of SAC was as under:
"In view of the above deficiencies. This SAC recommend withdrawal of EOA A/Y 2015-16. The students may be shifted to nearby AICTE approved institute as per AICTE norms".
19. Whereas, a Speaking order was issued 13.10.2015 to the institute based on the recommendation of SAC for implementation.
20. Whereas, the institute has applied for the restoration of intake during A/Y 2016-17.
21. Whereas, EVC conducted to the institute on 04.04.2016, as per the procedure given in APII 2016-17 for restoration of intake. The EVC noted nos. of deficiencies.
22. Whereas, the case was placed before the SAC on 18.04.2016 in which institute representative was also present. The recommendation of SAC are as under:
